**RESOLUTION NO. 2015-03**

**RESOLUTION AUTHORIZING THE UTE PASS REGIONAL  
AMBULANCE DISTRICT TO DO BUSINESS UNDER THE  
TRADE NAMES "UTE PASS REGIONAL PARAMEDICS"  
AND "UTE PASS REGIONAL COMMUNITY PARAMEDICS"**

WHEREAS, the Ute Pass Regional Ambulance District ("District") is a quasi-municipal corporation and political subdivision of the State of Colorado and a duly organized and existing special district pursuant to Title 32, Colorado Revised Statutes; and

WHEREAS, pursuant to District Court Order of Approval to Transact Business Under a Trade Name, dated July 27, 2006, the District has been doing business as the Ute Pass Regional Emergency Medical Service; and

WHEREAS, the Board of Directors ("Board") of the District hereby finds and determines that upon approval of the District Court to formally change the name of the District to the Ute Pass Regional Health Service District, as previously approved by the Boards of County Commissioners for Teller, Douglas and Park Counties, the District should conduct business as the "Ute Pass Regional Paramedics" under the District's emergency medical and ambulance service division; and the mobile integrated health service division of the District should conduct business as the "Ute Pass Regional Community Paramedics"; and

WHEREAS, upon approval of the District Court to formally change the name of the District, the Board desires to discontinue the use of the current trade name "Ute Pass Regional Emergency Medical Service"; and

WHEREAS, the Board hereby finds and determines that the use of such trade names and discontinuance of the current trade name is appropriate and necessary to the function and operation of the District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Ute Pass Regional Ambulance District as follows:

1. Upon the District Court's Order changing the name of the District to the Ute Pass Regional Health Service District, the District is authorized to do business as the "Ute Pass Regional Paramedics" under the District's emergency medical and ambulance service division; and is authorized under the mobile integrated health service division of the District to conduct business as the "Ute Pass Regional Community Paramedics".

2. The District is authorized to discontinue the use of the trade name "Ute Pass Regional Emergency Medical Service".


3. Counsel for the District shall petition the District Court for an order approving the use by the District of such trade names and discontinuance of the current trade name, and requesting the Court approve the registration of such trade names with the Colorado Department of Revenue.

4. **Severability.** If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.

APPROVED by the Board of Directors of the Ute Pass Regional Ambulance District at its regular meeting convened on May 5, 2015, by a vote of 5 in favor, and 0 opposed.
